ELIGIBILITY AND PROGRAM REQUIREMENTS

ENROLLMENT

Undergraduate (Junior or Senior) and graduate students are eligible. Students must be enrolled in an academic program at a U.S. college or university at the time of application with a minimum GPA of 2.5.

FEMA ICS COURSES

Interns are required to complete several FEMA ICS Courses and submit certificates of completion before the mid-way point of the program.

END OF THE TERM PRESENTATIONS

Interns present the work of their internship to their cohort and agency peers.

- Writing sample of your choice (5 pages max.)
- One (1) letter of recommendation on **official letterhead** from an academic or professional reference
- Proof of enrollment in an undergraduate/ graduate program, which is supported by:
 - 1. Transcript that shows student's anticipated graduation date
 - 2. An official letter from school administration (NOT a professor) stating the student's anticipated graduation date and that they are in good standing.

To apply, you must be a U.S. citizen. Applicants are subject to a background check.
